In terms of the provisions of Sections 108 and 110 of the Companies Act, 2013 (the "Act") read with the Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014, as amended from time to time, the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, Secretarial Standard–2 on "General Meetings" issued by the Institute of the Company Secretaries of India ('SS-2') and approved by the Central Government and other applicable laws and regulations (including any statutory modification(s) or re-enactment thereof for the time being in force), I was appointed as Scrutinizer by the Board of Directors of **Fortis Malar Hospitals Limited** ('The Company') through resolution by circulation dated January 04, 2020 to conduct the Postal Ballot/e-voting process in a fair and transparent manner in respect of the following resolution as mentioned in the Postal Ballot notice dated January 04, 2020:

Reclassification of Members of The Promoter/Promoter Group to the Public Shareholder Category

I submit my report as under:

- The Company completed dispatch of Postal Ballot Notice(s) and Postal Ballot form(s) along with all requisite documents on January 10, 2020 to its Members, whose names appeared in the Register of Members as on January 03, 2020 ('cut-off date') in the following manner:
- a) through e-mail to the Members whose e-mail lds were registered with the Company/ the Depositories; and

- b. through physical mode, along with a self-addressed postage prepaid business reply envelope to the other Members (whose e-mail addresses were not registered with the Company/ the Depositories).
- 2. The Company published an advertisement regarding dispatch of Postal Ballot form(s), notices etc. in an English Daily "Business Standard" having countrywide circulation on January 11, 2020 and Punjabi language Daily (being vernacular language of Punjab) "Rozana Spokesman" having wide circulation in Mohali, the district where the registered office of the Company is situated, on January 11, 2020.
- 3. The Members of the Company holding shares on January 03, 2020 had an option to vote either through Postal Ballot form(s) or through e-voting facility. Members who opted for e-voting facility have cast their votes on e-voting platform provided by KFin Technologies Private Limited (Formerly known as Karvy Fintech Private Limited) ('KFin') at <u>https://evoting.karvy.com.</u>
- 4. The e-voting was maintained by KFin in electronic registry and there was no shareholder who opted for voting through physical postal ballot.
- 5. The electronic voting process was monitored by me through the scrutinizer's secured link provided by KFin on its designated website i.e. <u>https://evoting.karvy.com.</u>
- 6. The e-votes were unblocked on February 10, 2020 at 05.00 P.M. in the presence of two witnesses, who are not in the employment of the Company.
- 7. The e-voting report generated from electronic registry of KFin has been entered in the Register maintained for that purpose.
- 8. All e-votes cast up to 05:00 P.M. on February 10, 2020, were considered for the purpose of this report. No Postal Ballot form was received till 05.00 P.M. on February 10, 2020.
- 9. For the purpose of this report, details of shareholding as on cut-off date has been considered. In case of shareholders who have voted for lesser number of shares as compared to their entitlement, the number of shares for which votes have been cast, have been considered.

- 10. All votes cast through e-voting mode on or before 05:00 P.M. on February 10, 2020 were matched with the Register of Members as on cut-off date maintained by the Registrar and Share Transfer Agent ('RTA') of the Company.
- 11. The total issued and paid up Equity Share Capital of the Company as on cut-off date was Rs. 18,74,17,590 (Rupees Eighteen Crore Seventy Four Lakh Seventeen Thousand Five Hundred Ninety Only) divided into 1,87,41,759 (One Crore Eighty Seven Lakh Forty One Thousand Seven Hundred Fifty Nine) Equity Shares of Rs. 10/- (Rupees Ten Only) each.

1. Overview

The excel utility can be used for creating the XBRL/XML file for efiling of Voting Result

XBRL filling consists of two processes. Firstly generation of XBRL/XML file and upload of generated XBRL/XML file to BSE Listing Center Website (www.listing.bseindia.com).

2. Before you begin

1. The version of Microsoft Excel in your system should be Microsoft Office Excel 2007 and above.

2. The system should have a file compression software to unzip excel utility file.

3. Make sure that you have downloaded the latest Excel Utility from BSE Website to your local system.

4. Make sure that you have downloaded the Chrome Browser to view report generated from Excel utility

5. Please enable the Macros (if disabled) as per instructions given in manual, so that all the functionalities of Excel Utility works fine. Please first go through Enable Macro - Manual attached with zip file.

4. Import XBRL file

1. Now you can import and view previously generated XBRL files by clicking Import XBRL button on Genenral

5. Steps for Filing Voting Result

I. Fill up the data: Navigate to each field of every section in the sheet to provide applicable data in correct format. (Formats will get reflected while filling data.)

- Use paste special command to paste data from other sheet.
- Use "Home" button (cntrl + H) to toggle between the sheets.

II. Validating Sheets: Click on the "Validate" button to ensure that the sheet has been properly filled and also data has been furnished in proper format. If there are some errors on the sheet, excel utility will prompt you about the same.

III. Validate All Sheets: Click on the "Home" button. And then click on "Validate All Sheet" button to ensure that all sheets has been properly filled and validated successfully. If there are some errors on the sheet, excel utility will prompt you about the same and stop validation at the same time. After correction, once again follow the same procedure to validate all sheets.

Excel Utility will not allow you to generate XBRL/XML until you rectify all errors.

IV. Generate XML : Excel Utility will not allow you to generate XBRL/XML unless successful validation of all sheet is completed. Now click on 'Generate XML'' to generate XBRL/XML file.
Save the XBRL/XML file in your desired folder in local system.

V. Generate Report : Excel Utility will allow you to generate Report. Now click on 'Generate Report' to generate html report.

- Save the HTML Report file in your desired folder in local system.
- To view HTML Report open "Chrome Web Browser" .
- To print report in PDF Format, Click on print button and save as PDF.

VI. Upload XML file to BSE Listing Center: For uploading the XBRL/XML file generated through Utility, login to BSE Listing Center and upload generated xml file. On Upload screen provide the required information and browse to select XML file and submit the XML.

6. Fill up the data in excel utility

1. Cells with red fonts indicate mandatory fields.

2. If mandatory field is left empty, then Utility will not allow you to proceed further for generating XML.

3. You are not allowed to enter data in the Grey Cells.

4. If fields are not applicable to your company then leave it blank. Do not insert Zero unless it is a mandatory field.

5. Data provided must be in correct format, otherwise Utility will not allow you to proceed further for generating XML.

6. Select data from "Dropdown list" wherever applicable.

7. Adding Notes: Click on "Add Notes" button to add notes
